Introduction



Hello! I am Jake.

I have been named after Elizabeth “Jake” Feinler, the first head of the ARPANET Network Information Center, the origin of the Whois protocol.

Project Jake seeks engineering solutions to complement and support existing DNS Registration Data disclosure policies and instruments, (including the RDRS). Key Principle: Support the implementation of existing policies, not making them.

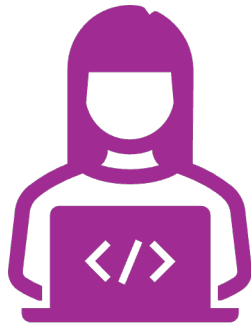
Since 2020 Project Jake has convened registries, registrars, requestors, policy experts, and technical leaders to collaboratively design workable, accountable frameworks for modern domain data governance.

Jake Key Elements



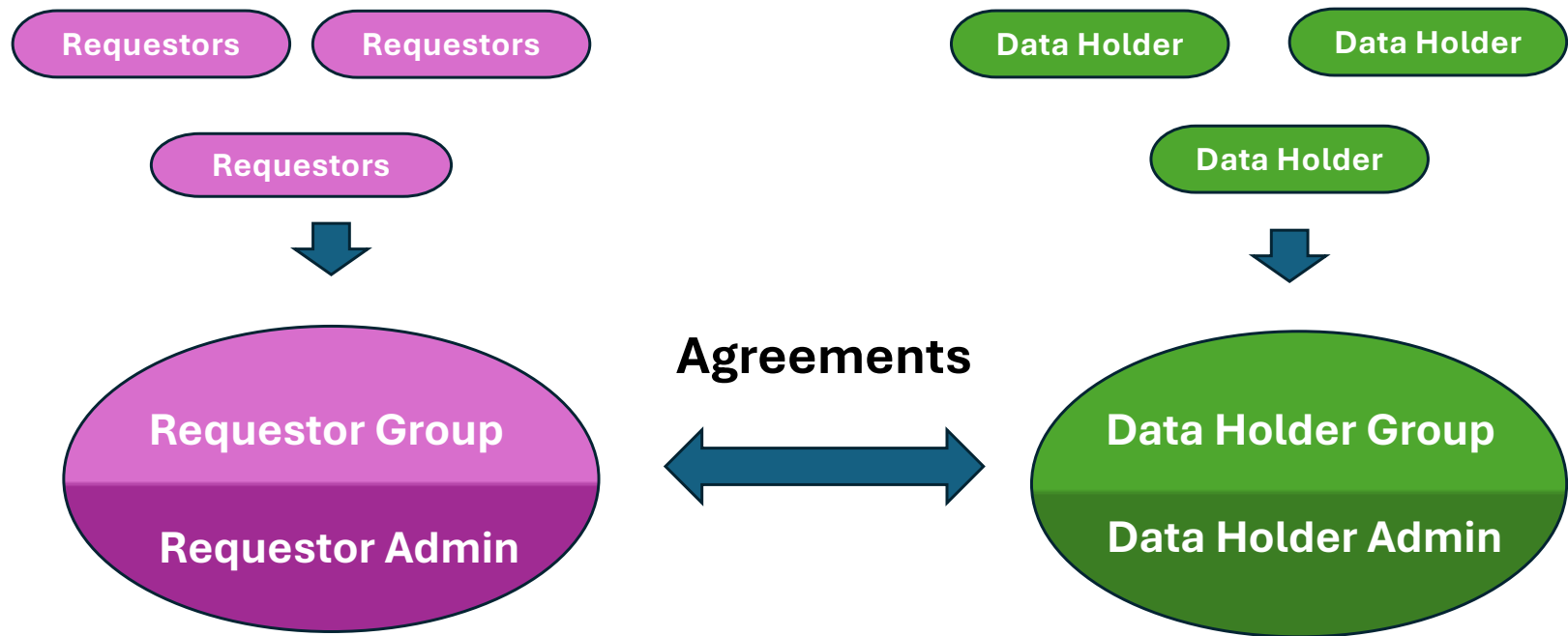
- **Requestors – Data Holders.** The challenge is balancing Rights with Responsibilities.

- **Agreements.** Agreements that manifest the Rights and Responsibilities of Requestor and Data Holder are at the heart of Jake.



- **Protocols.** Jake has developed an operational framework and protocols to help execute the Agreements

Stakeholder Operational Framework



Agreements



Agreements contain general Terms and Conditions and one or more Request - types.

Each Request-type includes:

- Purpose, e.g. investigation, market research, consumer protection
- Permitted Uses
- Access level, consistent with Purpose
- Expected Data Elements, consistent with Purpose
- Additional Parameters



Jake Protocols

Layer 1: Request and Response protocol

Layer 2: Agreement

Layer 3: Community Sharing

Will be publicly documented

Project Jake Software (based on Protocols)

- **JADDAR:** Requestor Software for making a request and receiving a response.
- **Group Manager:** Requestor Group Admin software to add and remove Requestors, and to enter into Agreements on behalf of Group

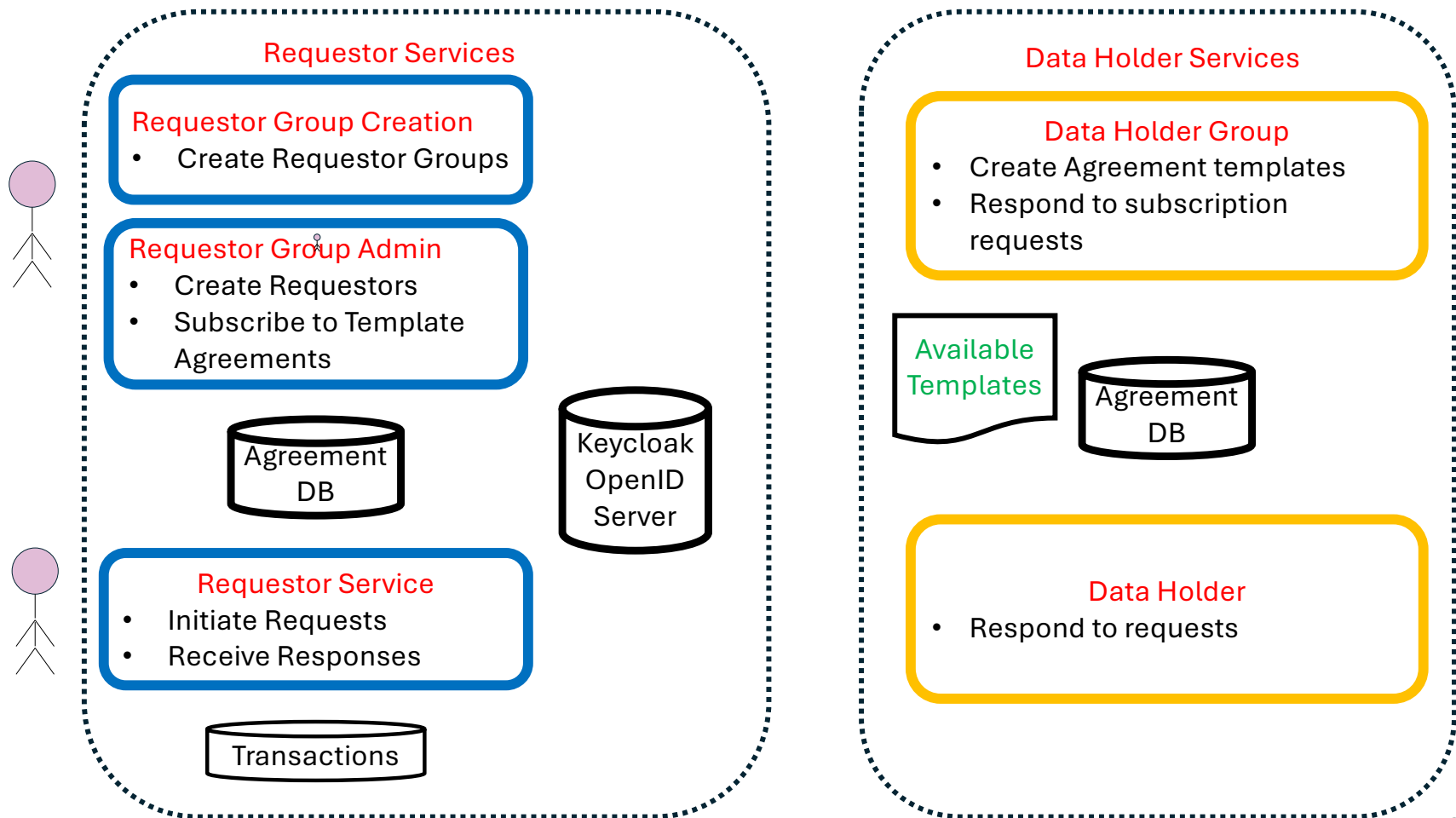

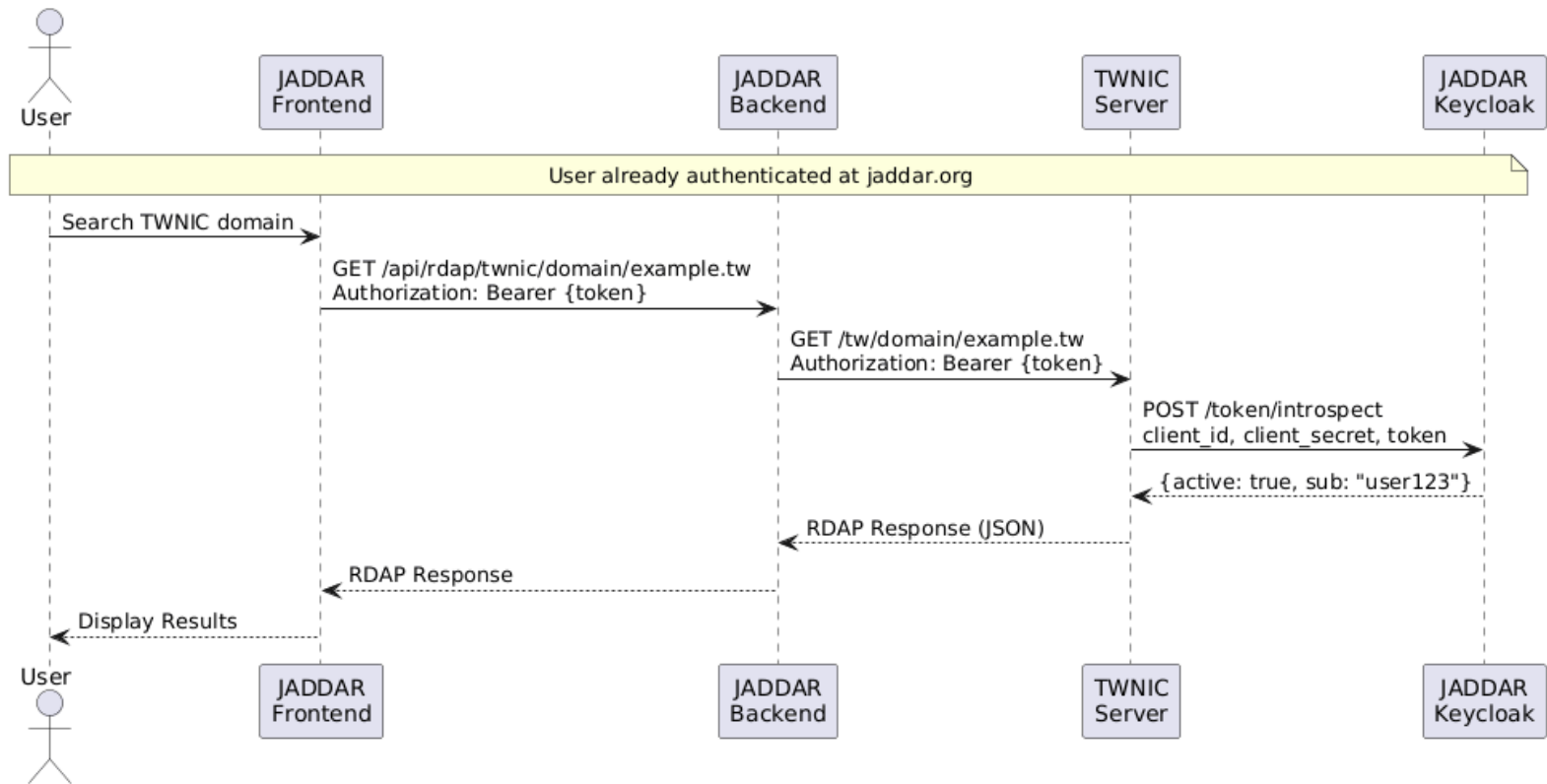








JADDAR to TWNIC RDAP Flow

Benefits for the Data Holder: Streamlined Access



Pre-Negotiated Master Agreements built around machine-readable agreements.



The Requestor Agent takes on the workload of verifying the identity and credentials of their users.



Permits selective automation or manual review of responses.

Benefits for the Data Holder: Total Policy Control



No Forced Policies: Data Holders can map their existing policy to the software.



Data holders input desired policy outcomes and set the technical "Sensitivity Levels".

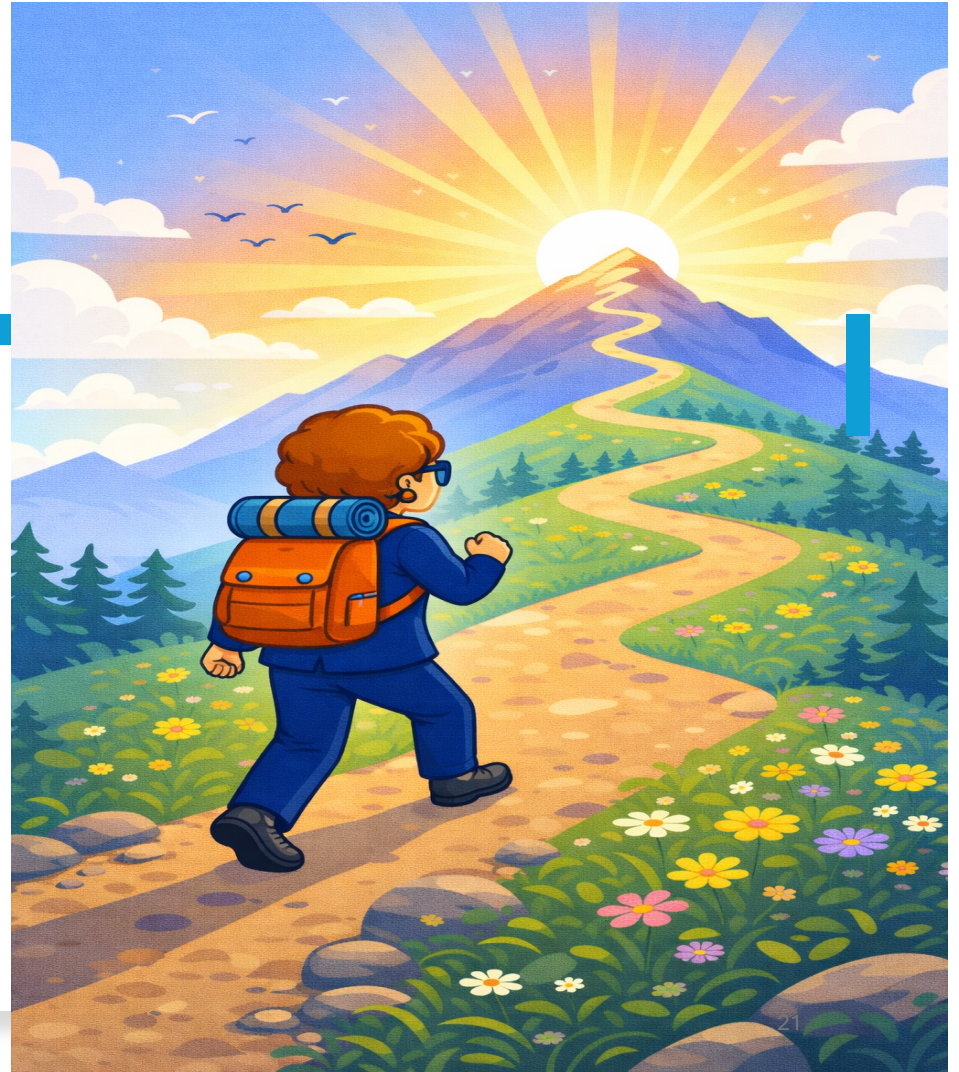


The configuration exports as a JSON file, can be integrated into the database.
